Project Description

The NMTC allocation will support the acquisition and construction of a 600,000 square-foot commercial and residential lawn care and snow removal equipment manufacturing facility in Fayetteville, TN. The project will allow a family-owned outdoor power equipment manufacturer, Ariens Company, to respond to a sharp increase in demand for its products by expanding its production capabilities. The project will serve as a hub for the company's brand of commercial outdoor power equipment and position Ariens to be geographically closer to its customers, dealer partners, and material suppliers in the Southeast, generating positive catalytic impacts in Fayetteville and the surrounding communities.

Job Retention/Creation (Permanent and Temporary)

The project will create 369 new full-time employment jobs (FTE's), which will pay average wages of \$19.42 per hour. Additionally, the construction and installation of manufacturing equipment associated with the Project will create 70 temporary construction jobs, which expect to pay an average wage of \$26.20 per hour.

Benefits/Training Opportunities: Employees are offered 10 paid vacation, 10 holidays, leave programs; medical, dental, and vision insurance; short-term and long-term disability; life insurance; paid maternity/paternity leave; 401(k) match and profit-sharing plans; bonus programs; accident and critical illness insurance; and flexible/health spending account plans. Employees can also take advantage of Ariens' voluntary wellness programs, employee product discount program, employee assistance program; gym discount membership program, tuition reimbursement, apprenticeship opportunities, and cross-training and job rotation opportunities.
